लोकलनंतर मुंबई शहराच्या वाहतुकीचा कणा समजल्या जाणा-या बेस्ट परिवहन उपक्रमाला प्रवाशांअभावी सध्या उतरती कळा लागली आहे. उत्तम सेवा मिळत नसल्याने प्रवाशांनी इतर वाहतुकीच्या सुविधांचा वापर करत बेस्टकडे पाठ फिरवली. मागील १० वर्षांपूर्वी बेस्ट बसने प्रवास करणाऱ्यांची संख्या ४५ लाखांच्या घरात होती, मात्र सध्या बेस्टची प्रवासी संख्या ३० लाखांवर आली आहे. प्रवाशांच्या माध्यमातून बेस्ट परिवहन विभागाच्या तिजोरीत ३ कोटी ७६ लाख १९ हजार इतका महसूल मिळत असे. मात्र आता प्रवाशांची संख्या १५ लाखाने कमी झाल्याने बेस्ट परिवहन विभागाला आर्थिक नुकसानीलाही समोरे जावे लागत आहे. यामागील असलेल्या कारणांचा आढावा न घेता बेस्ट प्रशासनाने थेट प्रवाशांना बेस्ट बसने प्रवास करण्याचे भावनिक आवाहन केले आहे. तर काही बस स्थानकांत प्रवाशांनी रिक्षा-टॅक्सीचा वापर न करता बेस्टचा प्रवास करावा अशा उद्घोषणा सुरू करण्यात आल्या आहेत.

मुळे बेस्ट परिवहन उपक्रमाची आर्थिक स्थिती अधिकच केविलवाणी झाल्याचे उघड झाले आहे.
